1. Chair

The Board Chair (JW) noted that three board members named Paul Wafer, Amisa Rashid and Diwakar Uprety had resigned in accordance with Article 27 (2) of the Article of Association. JW also proposed **Winnie Owako** has been re-elected for her first term and has also been appointed to the **People Committee**. and this was seconded by JD. All Trustees were in favour of the re-election.
